MICHAEL R HARVEY, MD CYTOPATHOLOGY

Dr. Harvey joined Incyte Diagnostics in 2019. He is board certified in anatomic and clinical pathology as well as cytopathology. He has special interest in gynecologic cytology and pathology as well as breast and thoracic pathology.

Dr. Harvey completed his undergraduate degree in chemistry at the University of Georgia in Athens. He then went on to complete his medical degree at the Medical College of Georgia, and was elected as a member of the Alpha Omega Alpha Medical Honor Society. He completed his anatomic and clinical pathology residency training at the University of Tennessee Medical Center, and served as chief resident.

Dr. Harvey then pursued a fellowship in cytopathology at the University of Vermont-Eletcher Allen Health Care where he worked with Dr. Gladwyn Leiman, MBBS. He was especially interested in human papillomavirus (HPV) testing on Papanicolaou samples. Dr. Harvey's research was presented at the American Society of Cytopathology annual meeting in 2006. Dr. Harvey also published a paper in the Journal of Clinical Virology regarding the clinical utility of the Invader HPV assay performed in SurePath Cytorich Red preservative fluid.

Dr. Harvey was a practicing pathologist previously in Tulsa, OK, where he was a member of his organization's executive team as well as being the medical director for Anatomic Pathology and multiple hospital laboratories. He serves as the chairman of the American Society of Clinical Pathology's CheckPath Clinical Pathology Committee and oversees the publishing of

quarterly CME cases in varied aspects of laboratory medicine. He is also involved with a software and intellectual property consulting software company that works with pathology groups to promote patient safety and pathologist effectiveness.
